### GENERAL COMMENTS

Verified 2007 national data shows 75% of 17 year olds in education/training – i.e. a standstill in relation to the previous year's data. Potentially more useful up to date local data modelling by Youth & Connexions service indicates that December 2008 figure was probably around 77%, with expected significant variations between clusters/14-19 localities – ranging from a high of 88% in High Suffolk to a low of 67.7% in Haverhill.

However the health warning is that DCSF calculations are hard to model locally with a high degree of accuracy, so Youth & Connexions estimate needs to be read with a measure of caution. Accurate local modelling is further challenged by the broader economic context, in particular, the possible impact of downsizing by employers on apprenticeship places, so 'amber' remains the most appropriate rating for this indicator. ### GENERAL COMMENTS

The latest performance data shows that Suffolk is performing at a very high level with the reduction in re-offending currently sitting at a 54% reduction against a target of 18%. This equates to a reduction of 177 offences against a target of 534 for the year.

The three PPO schemes in the county based at Ipswich, West (Bury St Edmunds) and East (Halesworth) Suffolk, have been subject to a review process and a gap analysis exercise which is now completed. This has resulted in a draft action plan which is to be completed and will be sent out for consultation with Partners. New corporate agendas have been created and they have been agreed and were used for all three schemes in June with success. Work to engage the Youth Offending Service has been successful and the new Deter strand is fully integrated into the three schemes. The Prison Service is currently being engaged and good progress is being made to have prison representation at all three schemes by September.

### GENERAL COMMENTS

2008/09 was designated as the baseline year for target setting for LAA LT6, as such no performance data is available for this period. The Safer Suffolk Delivery Partnership Board meeting has agreed that the indicator used to measure this target would be derived from Homeshield Referral data. A baseline was established using the most relevant available data which covered Oct-Dec 2008. This indicated that 87.5% of respondents reported that they did feel safe and secure in their own homes. The Board agreed to target an increase to 90% by the end of 2010/11, with the 2009/10 milestone set at 88.75%.

Activity to support the delivery of the indicator has been informed by surveying undertaken by Age Concern and includes the development of the HomeShield Plus scheme, SFRS carrying out fire home safety checks and a faster response to adaptations in the home.

**GENERAL COMMENTS**

Performance against this target is currently poor, in the first 12 months of the LAA2 period the number of offences has increased to a total of 1395 offences, 43 offences above the baseline. It will now be necessary to achieve a 10% reduction over the next 2 years in order to meet the target. Analysis of the targeted crime type has identified Ipswich, Lowestoft and Newmarket as specific areas where offending is concentrated. The GO-East Tackling Violent Crime Coordinator, with some support through a consultant, has been commissioned to undertake a focussed multi agency analysis of current activity within these areas with a view to identifying gaps when compared with "best practice" and then seeking to fill the gaps. This holistic review of the whole Night Time Economy issues in these locations which will then inform action planning. Suffolk Primary Care Trust have provided funding of £50k to support delivery of LAA LT7 with a view to implementing interventions which will lead to reduced use of NHS services linked to alcohol. This funding was only made available at the end of March 2009 so this project is at the very early stages.

### GENERAL COMMENTS

The Place Survey can be broken down to age group and ethnicity, but only one question is asked: "How often do you undertake unpaid activity: 1 week a year; 1 month a year, etc, etc" - therefore there is no data related to supported volunteering or specific to culture and sport in this survey. The Active People Survey can be broken down by age group, disability, and gender - but not ethnicity. This survey asks "do you undertaken volunteering in sports activity for at least one hour per week" - so this could be used to extract levels of volunteering for sport. The Volunteering England Annual Return provides a count of Volunteer Centre volunteers. This is an indicative measure of volunteering in the county, however, it should be noted that only a small proportion of volunteers are placed through the Volunteer Centres. Discussions are taking place about how to use the Place Survey, the Active People Survey and the Volunteering England Annual Return as a way of measuring the different elements of LT1. Although it should be noted that there are currently gaps in data which may make measuring all elements difficult.
