2. Notes of the Last Meeting held on 2 April 2009 and Matters Arising

The notes of the last meeting were approved with one amendment which had been emailed in by Dawn Girling.

The minute attributed to Dawn Girling in section 4 was incorrect. The text "*She noted that the PMG was the right vehicle to move performance at delivery level.*" should be amended to read "*She noted that PMG appeared to be fulfilling the role of an executive group following the earlier reorganisation, but suggested it was right to question whether PMG was the correct or most appropriate group to assess the fuller aspirations of the Community Strategy.*"

There were no matters arising.

3. Chairman's Remarks

Clare Euston noted that the formal part of the meeting would be brief to allow members to move through for the discussion and debate on the rule of local law with a large number of invited guests from across the county, and across the professions and voluntary groups working within the criminal justice system

4. SSP & Voluntary Sector Manager's Report

Clare stated that she regretted there was not in depth report for the Board at this meeting on performance, but stressed that she had been assured that there will be for the next meeting, which will mark a year since the Delivery Partnerships were set up. Clare advised that the Chair of the Performance Management Group would report comprehensively to the board at the next meeting.

Clare acknowledged the concern expressed by members on the lack of progress on some of the delivery partnerships, and whether the PMG is working well or could be improved. Some board members expressed their concern regarding the delay and confirmed the requirement for a full proper report at the next meeting.

Clare referred to the proposal at the last meeting that the board should develop a small executive group to meet monthly to expedite business. Clare noted that Richard had pursued this as asked, and his comments were included in Paper B. Richard referred to Paper B and the various conversations he had with members and highlighted the proposal for the proposal of a small executive group to be discussed as part of the away day planned for November 2009. Following brief discussion it was agreed that the points raised and further considerations about local government review and wider challenges would inform the away day where the board could fully consider changing its approach.

Clare stated that it was no exaggeration to say that she had received an avalanche of concerns about the process that has been adopted and the criteria for funding the Performance Reward Grant. A proposal was made that Clare should collate the concerns expressed directly to her and circulate to all board members, with space for members to offer solutions. It was agreed that Clare would draft this together and Richard would circulate.

Members discussed the issues regarding the Performance Reward Grant and Stephen Singleton expressed his concern that the delivery partnership national indicators are being used to inform decisions, not the community strategy. It was stressed that the process needs to be open, transparent and offer a full assessment of spend.

It was stated that a new approach was needed to commissioning and that there was currently too much misunderstanding. It needs to be asked if projects can help meet our targets within the community strategy.

Jonathan Moore queried whether this was something Stephen Singleton and The Suffolk Foundation could pull together for future years. Discussion led to a proposal that Stephen Singleton could lead a programme to review for next year which was supported by members.
